

All fees listed below are due at the time of registration and will be invoiced by FACTS after you have completed and returned the AMCS Tuition Contract, which will be emailed to you after completion of your online pre-registration. Completion of an AMCS Tuition Contract, remittance of fees, and set up of a FACTS tuition payment plan are all required in order to finalize enrollment.

Fees due at time of registration:

- **\$350.00** Enrollment/Assessment Fee **per NEW student** (applies to **ALL NEW Kindergarten - 8th grade students**)
 - **\$150.00** Assessment fee only per **Kindergarten student that was enrolled in AMCS Preschool**
 *Upon enrollment of a new student, \$150 of the paid FACTS online application fee or payment remitted to the school office will be applied to the enrollment or assessment fee listed above
- **\$375.00** Registration Fees for **ALL K-8 students**: These fees will be used for various student expenses such as books, technology updates, health office supplies, class specific expenses/supplies, room parent reimbursements, etc.

We are in the process of reviewing our fee structures, so these fees may be subject to minor changes

* **New Families**: To be considered for the affiliated Catholic parishioner tuition rate, each family must actively participate in their Catholic faith and be registered at a Catholic parish. Refer to the *Confirmation of Catholic Parish Affiliation New Families* form found in your online enrollment packet. A tuition rate adjustment can be made to your tuition contract after you turn in this completed form signed and dated by your Catholic parish pastor.

Tuition payment options with FACTS:

- Monthly payment plan: 10 or 11 month plans available (June/July 2024 - April 2025) for a \$50 annual enrollment fee
*Please note that fewer payment plan months will be available if completing enrollment after July 2024
- Semi-annual payment plan: payments due August 2024/January 2025 or September 2024/February 2025 for a \$20 annual enrollment fee
- Annual payment plan: payments due by July 15, 2024 for a \$20 annual enrollment fee
*Please note that full tuition will be due the month following your completed enrollment if after July 2024

FINANCIAL ASSISTANCE: Applications will be available beginning January 1, 2024

If you are interested in applying for financial aid consideration, please begin at www.factsmgt.com and follow the instructional prompts for financial aid. These applications are needs-based and will require submission of various financial documentation in addition to your completed online application.

Deadline date for 1st round applications is April 15, 2024. Late enrollments can apply until June 30, 2024 for 2nd round award consideration, but the majority of the funding will be awarded based on applications received by the April 15, 2024 deadline, so any 2nd round awards will typically be less, even if you demonstrate need.
